Eric Bump said he tried to contact the Association of Town regarding squatter legislation and did not receive a response.

Rachael Davis said that a new law was passed by Governor Hochul giving owner's rights to change the locks had been passed.

Russell is going to look at putting the highway superintendent position on the ballot. He also said the FEMA payment is under review and once it is approved the future payments should process quicker.

Lanny Newell said the dumpsters were out of control this month and that we need a fence.

The board would like an ad put in the paper stating that the dumpsters should only be used during daylight hours and for Rathbone residents and land owners only and that violators will be prosecuted.

Russell said that he received notification that the dog kennel had passed inspection.

Eric said the county came and fixed the excavator and it was extremely expensive for the part that could have been purchased for much less online. He also wondered if the town could get a card at Harbor Freight so that the tools could be replaced since there aren't many tools in the shop.

During the public comment, Jill Risley asked if the potholes at the end of Saunders by the Yarka's home had been repaired. Russell said he would ask for those to be fixed. She also asked if the maintenance logs were being used. Lanny said they were being used currently.

Russell said that no Item 1 has been presented to the board by Dan Barney so it has not been approved.

Eric asked if the internet was working. The town clerk explained that the problem is that the internet enters in her office and the router is located there. She spends time every day restarting the internet. That it had been working fine for a long time and she wasn't sure what the problem was. Time Warner provides this service for free because Dan Farrand negotiated it in the franchise agreement.

Eric said we need a water tank for a truck for the summer.

Russell said if it is over \$2,500. We need three quotes.

Duane Miles asked if Eric Bump was mitigating for the highway department. He said he is down at the highway barn often and Dan Draper has asked him to ask the board questions.

Eric asked if we could do away with the highway employees probation period. Russell explained there is no longer a benefit after the probation period is over.

The board asked that an add for the utility worker could be put in the paper with interest being expressed between May 13 -17th to start on May 20th.

Duane Miles asked what the budget transfer had been for. Russell explained that it was just between different personal service lines for payroll. He also asked if we were renting the sweeper on the loader. Lanny said they were. Duane asked how much? No one knew for sure. Duane asked what the hydraulic oil on Hubbard Road was. Lanny said the hose broke because the hose was dragging. He also said he felt the broom doesn't work that well on crowned roads.

Mike Knapp said that there is no crown on our roads.

Eric said he was looking into CERT (Civil Emergency Response Team) for help when disasters that may occur within the town.

Gary Baker asked who has the liability for the bucket truck when Addison is using it. Russell said it was insured.

The town board moved into executive session at 7:12 pm.

Once back in the board meeting, Russell asked if there was any further public comment. Gary Baker stated that the F250 looked disgusting, and the employees should clean the trucks when they get done using them.

With no further comment, Eric Bump motioned that we adjourn at 7:28pm seconded by Rachael Davis
